### **B. Manager's Report**

- Q. What is the timeline for Keen Creek?
- A. Depends on snow. Menglers have about 4 ha left over. Approximately one month left there.

Q: Regarding timber in Nashton Creek.

A: Nashton Creek has great wood but likely heli access and very difficult terrain. Only 12 ha on that face, not the end of the world to not harvest.

Q. What are you burning up lost ledge?

A. Burning the brush piles from the road work last year. Also will be burning the piles in the CP 46 cutblock. Site prep next week and burning piles. Have to deactivate skid trails and pile as we go. Learn from plantations up Briggs Creek that were lost because they were quite slashy as Briggs was logged when snowy. clean as you go.

Q. Where will we be on our 5 year AAC?

A. We will be under again.

Q. Who is Blackwell?

A. Collaborating with Cathro consulting on Community Wildfire Resiliency Plan (CWRP) and specialize in wildfire risk mapping. A large forest consulting firm out of Vancouver that has worked in wildfire risk reduction for years.
