Treasurer Report

Good conversion made pulp more profitable than anticipated. Operations are done up Keen Creek for now and will reassess in the winter.

Investment of about 180K in road work that will help us turn profit in operations in the next five to ten years.

B. Manager's Report

- Q. How far in is road?
- A. Brushed 8 km past the bridge, may do more, but working on contractors. Upgrade roads as we need, a couple spurs to build maybe, road needs a lot of work, about a month or more. Try to have blocks ready in case the road is too greasy to haul.
- Q. How do we revisit previously logged areas?
- A. Yes, regen surveys must be done one year within regen surveys.
- Q. How do we go about having a healthy stand after a forest fire?

- A. Many variables make it stand dependent including, site conditions, seed source, self pruning, timelines. There are pros and cons of fire salvage. We harvested about 4% of the burnt area up Keen Creek
- Q. How do we log and prepare for fire at the same time?

A.Again, site specific, proximity to assets, can broadcast burn slash. Discussed reburnt fire at Hammill Creek.

Q. How is silviculture coming?

A.A bunch of blocks ready to declare free growing, Craig doing some surveys, some brushing, etc. Working out well with the contractor who is performing surveys and brushing work.

Q. Location of 2ha on Buchanan?

A.Bottom of Wardner to up above the access trail. Lots of dead fir, lots of it what you want to see already douglas fir, maple. Cut and burn, will put together a more comprehensive plan because of proximity to town.
