A. Treasurer's Report

Q. Anything stand out? Expecting much money in/out in December?

A. A bit out, I think we'll be a bit better than projected. At least we're inside budget numbers.

- Q. How many cubic meters have been harvested in 2023 all together?
- A. Just over 6,000 m3 . All pulp except maybe 10 loads.

Q. How are 2024 projections looking?

A. Depends on markets and road work etc. 2023 negative figures are spending on development, maintenance, and getting prepared; setting foundations for future profits.

- Q. How much was road work up lost ledge?
- A. \$ approximately \$350,000.
- Q. Does the Community Forest defer these costs?
- A. No, best to keep in one year.

B. Manager's Report

Q. Is \$8 per cubic meter for silviculture enough?

A. Management is watching it and will adjust if necessary.

Q. Village of Kaslo Christmas tree request.

A. Chris Webster suggests Martin at the old Dalin Christmas Tree Farm and will send contact to Jeff to make arrangements.

Q. What's in our current fire inventory?

A. Inventory includes hoses and jewelry, pumps, and bladders. Board members expressed support for storing the equipment sea can on Brenton's lot.

Q. Where?

A. Mostly along the North side of the creek on the bench and some on the south side.

Q. If they use the bridge and access then they should participate in costs that we've had. A. Yes, KDCFS would enter into an agreement for road cost and maintenance. Potentially future costs as well.
